THE MEMBER AGREES

1. To accept liability for items borrowed from Community Health Information Centre until such items are returned to the Community Health Information Centre.
2. To return items by the due date in an undamaged condition. In the events that items borrowed from the Community Health Information Centre are not returned by the agreed date, the borrower shall be required to pay a charge of **\$2 per item for everyday they are overdue** as specified by Community Health Information Centre until the items are returned. Such a charge shall be due and payable on return of the items or when borrowing next time.
3. To pay unpaid charges and any costs for repairing or replacing any lost or damaged goods borrowed from the Community Health Information Centre for the purpose of this agreement, items shall be deemed lost or stolen if it is not returned to the Community Health Information Centre within 14 days after the due date of return. The cost of the repair or replacement of items shall be paid by the borrower to Community & Public Health Ltd.
4. To authorise Community & Public Health to charge him/her for any amounts due for late returns, damaged or lost items
